AN ORDINANCE AMENDING AND SUPPLEMENTING CERTAIN PARKING REGULATIONS OF THE GENESEO TRAFFIC CODE AND ZONING ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GENESEO, HENRY COUNTY, ILLINOIS:

1. Title VII, Chapter 71, Section 71.073(B)(1) of the City Code is hereby amended and supplemented to provide the following:

(B)(1) Subject to the provisions of Section 72.08 of the Title VII, Chapter 72, of the City Code, it is hereby unlawful to park any vehicle on any street or highway or any public parking area for a period of longer than 72 consecutive hours.

2. Chapter 7, Section 9-7-1, Subsection (H)(2) of the City of Geneseo Zoning Ordinance regarding parking of trucks, is hereby repealed and vacated.
3. This ordinance shall be in full force and effect from and after its passage and due publication in pamphlet form as provided by law.
4. All ordinances or parts thereof in conflict herewith are hereby expressly repealed to the extent of said inconsistency.
