AN ORDINANCE PROHIBITING THE POSSESSION OF CANNABIS IN THE CITY OF GENESEO


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GENESEO, HENRY COUNTY, ILLINOIS:

1. The terms used herein shall be defined as set forth in 720 ILCS 550/3, the Illinois Cannabis Control Act.
2. It is unlawful for any person knowingly to possess cannabis within the City of Geneseo.
3. Any person violating this Ordinance by knowingly possessing cannabis in an amount of 10 grams or less shall be subject to the provisions of Title I, Section 10.99, of the Geneseo Code of Ordinances.
4. This ordinance shall be in full force and effect from and after its passage and due publication in pamphlet form as provided by law.
5. All ordinances or parts thereof in conflict herewith are hereby expressly repealed to the extent of said inconsistency.


