#### Discussion on Ordinance O-18-01 An Ordinance Declaring Bed Bugs a Nuisance.

Doug Emerick of Emerick Pest Control presented his opinion on putting an ordinance in place to cover bed bugs. Emerick communicated that you can't protect everyone, there are 1500 units throughout the Quad Cities that are treated for bed bugs. He stated that it would be pretty hard to force landlords to inform tenants if there is a problem. He stated that by the time some one moves out and the unit is cleaned they have eradicated any evidence of bed bugs. They look like a tick and are not easy to find, they come out to feed between 2 and 5 am and can be dormant for a year. They don't carry any disease and are not a dirty bug. It is hard to prove if a new tenant brought the bugs with them or if they were already there. It costs an average of \$1,500 to treat a 4-bedroom house. There are no communities that he knows of that have such an ordinance regulating bed bugs.

### Discussion on water department capital budget change, water tower cleaning to Scada System.

The current budget process includes a spreadsheet of capital expenses, this allows departments to finance such capital expenditures without coming back to Council. The water tower maintenance has to be postponed due to the new well not being on line yet so instead Chad would like to use those funds to update the Scada System that they currently have from radio transmission to fiber. This will bring online all the water facilities and wells which can be monitored by the water department instead of being monitored by the Electric Department and then being passed on to the water department employees. The water chemical controls would then be documented on the server for report use when needed.

Motion by Johnson, second by Robinson to recommend to the City Council a capital purchase transfer in the Water Department from Water Tower Cleaning and Painting to a new SCADA System for the Fiscal Year 2018 in the amount of \$100,000.00.
