# ORDINANCE NO. O-18-23 2018 TAX LEVY ORDINANCE FOR THE CITY OF GENESEO, HENRY COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING JULY 1, 2019 AND ENDING JUNE 30, 2020

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GENESEO, ILLINOIS:

**SECTION I:** There shall be levied upon all property subject to taxation within the corporate limits of the City of Geneseo as that property is assessed and equalized for state and county purposes for the current year the amounts hereinafter set forth as budgeted or deemed necessary to defray additional expenses and liabilities for all corporate purposes or so much thereof as may be authorized by law, for the City of Geneseo, Henry County, Illinois, for the fiscal year beginning July 1, 2019 and ending June 30, 2020.

**SECTION II:** The specified amounts as levied for the various objects or purposes are placed in a separate column designated, "Amount To Be Raised From Tax Levy"
